The DuSable Museum of African American History is pleased to make reproductions of images from its collections available for personal and scholarly use. A very small percentage of images are available in digital format. There will be a **\$50.00 processing fee** charged to each individual or institution making the request. Items reproduced for commercial purposes may be subject to the copyright restrictions detailed below.

Our staff will photograph copies of items that are not available in digital format, but the requester will be responsible for all photography and reproduction costs.

All requests for image reproductions are governed by the following conditions:

- 1) Reproductions are provided for one-time personal use, research purposes or publication/exhibition only. Requesters wishing to use the same images for another use must make a separate request.
- 2) All images used in printed publications, on film and video, on Web sites and in exhibitions are credited with the following: Courtesy DuSable Museum Collection.
- 3) The requester is to give the DuSable Museum of African American History one complimentary copy of any published work in which the reproduction occurs.
- 4) In authorizing the publication of the reproduction, the DuSable Museum does not surrender its own right to publish it or to grant others permission to do so.
- 5) The DuSable Museum reserves the rights to limit the number of reproductions; restrict the reproduction services to archival materials only; restrict the use of rare or fragile materials; and institute additional fees for items requiring special handling.
- 6) Exceptions or additions to these conditions appear below and are a part of the conditions governing the use of reproductions provided by the DuSable Museum.

Warning Concerning Copyright Restrictions

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.
